SYED AMEER ALI

The first mosque in Britain was established by a member of Inner Temple, Syed Ameer Ali (Called 1873). He practiced at various times as a law lecturer, barrister and Judge in Calcutta before returning to London to pursue his legal career. Until 2009 he was the only muslim to have been privy councillor. A full appreciation of his life and times will appear in the Yearbook later this year.

LEGAL EDUCATION AT THE INNER TEMPLE: AN INTERNATIONAL DIMENSION



The Inner Temple has always been at the forefront of the international dimension of the law and we now have a number of students from Central and Eastern Europe studying with us. We are keen to promote this aspect of the Inn's work and to do this we aim to gain a better understanding of the needs and wishes of other jurisdictions. On Wednesday 21 March, the Inner Temple hosted a seminar in association with Allen & Overy LLP, inviting around 30 lawyers representing 12 Eastern European countries, including Lithuania, Albania, Ukraine, Romania, Croatia, Russia, Poland and Hungary.

Talks were given by Master Treasurer, Master Beringer, the Sub-Treasurer and Master Francis. We then heard from Romanian and

Polish student members about their experiences studying for the Bar of England and Wales. There was also a particularly interesting and informative roundtable discussion, which better improved our understanding of legal education in the countries represented. This was followed by an informal dinner where discussion of mutual collaboration continued, along with a less formal opportunity to get to know our European colleagues!

Our thanks go to Master Beringer for his contribution to organising the event and to Stephen Denyer, Global Markets Partner at Allen & Overy LLP, for chairing the roundtable discussion and facilitating links with leading practitioners from Eastern Europe.

RESEARCH AND CONSULTATIONS

The Inn is working continually to strengthen its data collection and statistical analysis in order to evaluate and monitor equality and diversity, trends relating to professional progression and to solicit the views of its membership groups. Having recently modernised its membership records and application procedures, the Inn will continue to connect with members on topics of concern for the profession.

This includes a recent survey of all of the Inn's Employed Barristers. Over one hundred have responded, suggesting where the Inn can improve its provision for those in employed

practice. We will seek to do further surveys with other membership groups in forthcoming months.

The Inn regularly produces research reports and responds to relevant consultations by regulators and Government. The Student Snapshot, for example, provides easily accessible statistics on student membership. The Inn has recently responded to consultations by the Bar Standards Board and Legal Services Board. These can be found on the Education section of the website.

POLICE OFFICERS LEARN ABOUT THE WORKINGS OF A CRIMINAL TRIAL

Under the Inn's Police Liaison Scheme, an annual event was held at the Royal Courts of Justice on 24 February 2012. The event, which aimed to inform police officers about the workings of a criminal trial, consisted of a talk on giving evidence, a mock trial with an open jury and a question and answer session. Nearly 60 officers attended from participating stations: Bishopsgate, Holborn, Islington, Kentish Town, Kensington & Chelsea and Wimbledon.

The Police Liaison Scheme gives student members the opportunity to accompany officers on patrol to learn more about the work of the police. So far this year, over 30 students have shadowed police officers, with many more visits planned. For police stations, selected officers are able to marshall a judge and

stations are invited to send officers to this session on criminal trials. The aim of the scheme is to promote good relations between the police, Bar and judiciary and foster a greater understanding of the entire criminal justice system. This is part of the Inn's larger outreach work, which includes work with schools and educational charities.

PEGASUS ACCESS SCHEME LAUNCH

Monday 12 March saw the launch of a new Inner Temple initiative - the Pegasus Access Scheme. Co-ordinated by the E&T Department in association with forty-four partnering Chambers, the scheme offers high-achieving students from under-represented backgrounds the opportunity to undertake formal mini-pupilages. The particular focus of this initiative is to encourage social mobility and diversity in the profession and ensure that students with the capability and determination to pursue a career at the Bar have equal opportunities regardless of their background or networks. This is the largest co-ordinated scheme of its kind at the Bar.

Patrick Maddams, Sub-Treasurer, said of

the scheme: “The Inner Temple has a long tradition of social responsibility and is dedicated to widening access to the Bar... This scheme will build on our outreach work with schools and universities. This national scheme demonstrates the breadth of commitment across the profession.” Master Dingemans, Chairman of the Inn's Outreach Committee, said of the scheme: “No one institution can address all of the issues

surrounding social mobility and access to the professions, but everyone has a responsibility to do what can be done to break down any potential barriers to entry.”

THE INNER TEMPLE INTER-VARSITY MOOTING COMPETITION 2012

On the 5 February, the Inn hosted its annual Inter-Varsity Mooting Competition. Despite being scheduled on a very snowy Sunday, teams and judges from across the UK and Ireland made their way to London to participate in the Inn's showcase competition, which was kindly sponsored by 3 Raymond Buildings and the ICLR.

The Inter-Varsity is open to all law undergraduate and conversion students. This year the Mooting Committee, who organise and run the event and others like it in the Inn, registered thirty-two teams. For many of the competitors, the competition presented an early or even first opportunity to experience the Inns of Court as well as to showcase their advocacy skills in front of eminent members of the Bar.

How seriously the competition is taken was quickly evident not only by the 9am arrival of participants even with the treacherous weather, but equally by the quality of the skeletons and bundles they turned up with. The mooting problem required submissions to be made on the admissibility of confession evidence gathered by the police using technological means and in breach of their statutory powers. This area of the law was deliberately chosen as one unfamiliar to those in the early academic stage of their legal career and it thus necessitated in depth and thoughtful research. For the vast majority of teams, the result of that research was argument founded on reasoned analysis and original application of principles and case law.

In presenting those arguments in the

rounds on the day, many competitors showed a huge amount of skill and potential as advocates, with the Mooting Committee and judges noting a number of truly exceptional individuals. The most persuasive of teams, from the Universities of Sheffield and Exeter, reached the Grand Final. In a moot of outstanding quality, it was the unanimous opinion of the judges that the victors were Exeter's team of James White and Michael Standing. James and Michael have been awarded not only with their title of winner but also a mini-pupillage at 3 Raymond Buildings and a subscription to the ICLR.

The Mooting Committee would like to thank a number of people who were instrumental in making the day such a success. All the judges who were willing to attend on the day were impressive both in their level of experience and sheer number. In particular, three judges contributed significantly with their expertise both throughout the day and also in the Grand Final. Those judges were Trevor Burke QC (3 Raymond Buildings), Alastair Hodge (5 Essex Court) and Daniel Parisi (TGL Shipley Parisi). The Mooting Committee also gained substantial assistance from the public speaking knowledge of Michael Harwood and Charlotte Davies. As always, the faultless hospitality facilitated by the staff at the Inn ensured all involved were well looked after.

The Inter-Varsity Mooting Competition will run again next year with applications for team registration being accepted in late October or November 2012.

INTERNSHIP SCHOLARSHIP IN ZIMBABWE

Zimbabwe is a country in which I've always been very interested. In undertaking voluntary work and internships since graduating from University, I have had the opportunity to examine its history and politics in some detail. As a recent university graduate, I'd studied political theory from the (relative) comfort of a library and chatted to Zimbabwean friends about their concerns and hopes for the country. And so when I was offered the opportunity to explore these things in Zimbabwe I enthusiastically seized it.

It was for these (and other, more mundane, hedonistic) reasons that I travelled, in the Summer of 2011, to Zimbabwe on an internship with (MDC) government Minister and Senator David Coltart, thanks to an Internship Scholarship award. Based in Bulawayo, the South-West counterpart to Zimbabwe's capital, Harare, I was able to observe, first-hand, issues of local politics, law, and development. In undertaking a range of work from administrative tasks to extended research projects, I moved between discussions on constitutional reform, city council meetings on local development, and football tournaments at a local school encouraging young people to register to vote.

Zimbabwe is a country whose recent history, I came to understand, is informed by multiple coalescing factors. Once named the 'bread basket of Africa' and boasting the best education system of much of the continent, a series of crippling IMF-negotiated public sector cuts and ill-judged domestic and military spending by the ZANU-PF government – alongside the recent destabilisation of one of the country's most profitable sectors, predominantly white-owned agriculture – has left much of Zimbabwe in poverty. This has been

punctuated by a series of violent crackdowns on popular dissent across the last decade. Now, Zimbabwe faces the prospect of an election, after a MDC-ZANU-PF coalition government was agreed in 2009, the (almost) interminable question of President Mugabe's health, and the portentous discovery of vast alluvial diamond reserves in Marange.

One recent tragedy which I explored first-hand was 'Operation Murambatsvina', a Shona (one of Zimbabwe's two most prominent languages) word for 'clearing away the filth'. In 2005, the government undertook a nation-wide campaign of devastating home demolitions, displacing hundreds of thousands of people already facing severe poverty. Felt by some to be the government's recognition of the MDC support such communities bore, many of those displaced still ostracism from the general population as a nuisance or are branded as 'criminals'. This was, nonetheless met in solidarity with many religious and activist groups, whose contributions to the piecemeal rebuilding of their lives was surely inestimable.

Admittedly, I was not especially well-equipped for the nuances of Zimbabwe's domestic political scene, and was often flummoxed by the interplay of party affiliation, seeming ethnic divides, economic complexities, and socio-historical narratives. Some things, however, were clear, notably the very obvious fact that Zimbabwe's political and civic body sustains a talented and courageous contingent of politicians, lawyers, academics, activists, workers, and citizens. Their struggles against violence, corruption, prejudice, and poverty were striking and profound. It was a privilege to learn (what I could) from them, but it was a greater privilege simply to come to know them at all.

INNER TEMPLE INTER VARSITY DEBATING COMPETITION 2012

On Friday 3 and Saturday 4 February this year, the Inner Temple Debating Society hosted the Inner Temple Inter Varsity Debating Competition 2012, kindly supported by Blackstone Chambers. 30 teams from across the country (and Paris), entered and competed in what has become for many, the highlight of the debating circuit.

The competition featured five rounds, a semi final and 'Grand Final' hosted in the main hall and judged by senior practitioners including Master Spens. All debaters across the first five rounds engaged with motions dealing with subjects as diverse as granting independence to Scotland to cancelling the Olympics.

What makes the competition truly captivating is the surroundings in which it is

situated. No other institution can boast a three course candle lit dinner, followed by a Grand Final judged by practising barristers. The competition was won by the LSE, after they successfully convinced the judging panel, and possibly all those in hall, why military intervention in Syria would be a good idea. This year, to make things particularly special, the Debating Society arranged for it to snow heavily in order that Inner Temple was able to appear even more impressive than normal!

THE PARIS BAR EXCHANGE

An exchange programme for barristers of all four Inns of Court who have been in practice for up to five years. The Paris Bar Exchange offers the opportunity to spend the month of September doing a stage in Paris. *Avocat* members of the Paris Bar of similar seniority spend the month of July doing a stage in London. The Bar of Paris with the Paris Bar School (EFB) offers the following stage to up to four Barristers:

- An introductory seminar and other activities at the EFB
- A stage in an *Avocat*'s office, preferably specialising in the Barrister's field of practice
- Attendance at hearings of both interlocutory injunction applications and criminal proceedings
- Visits to the Palais de Justice, an administrative tribunal or the Conseil d'Etat with some marshalling
- Meetings between young *Avocats* and Barristers and a reception
- Conducting a mock trial in the Palais de Justice in French before French judges

STUDENT RESIDENTIAL WEEKENDS

The Inn recently held the last of its three residential weekends for students. Each weekend has been extremely successful in providing an opportunity for students to meet senior members of the Inn and develop their advocacy skills in a relaxed and informal atmosphere. Each weekend was themed with students hearing from high profile experts in the area of law under discussion.

The December weekend, entitled *A Public Law Debate: Prisoners’ Rights – What Rights?* considered the legal rights of prisoners. Speakers included Dame Anne Owers DBE (Chairman of Clinks, former Chief Inspector of Prisons and former Director of JUSTICE), The Rt Hon The Lord Carlile of Berriew QC (President, The Howard League for Penal Reform), Hugh Southey QC (Tooks Chambers), Robert Buckland MP (Barrister and Conservative MP for Swindon South) and Libby Purves (broadcaster and journalist).

The weekend in February, entitled *Witnesses: Trials and Tribulations* examined the position of vulnerable witnesses in the legal system. Students heard from David Hines (Chairman, National Victims’ Association) Professor Michael Lamb (Head of Department of Social and Development Psychology,

University of Cambridge) Master Spencer (University of Cambridge, Faculty of Law), His Honour Judge Peter Rook QC, Geraldine Monaghan and Mark Pathak (Social Work Senior Practitioners), and Master Maddison.

The final weekend in March, entitled *Integrity in Sport – Uneasy Bedfellows?* examined issues surrounding the regulation of professional sports, touching upon the upcoming London Olympics. Speakers included The Honourable Michael Beloff QC (Blackstone Chambers), Max Mosley (former President of the Fédération Internationale de l’Automobile and former barrister), Michele Verroken (Director, Sporting Integrity and Former Director of Ethics and Anti-Doping at UK Sport), Jonathan Taylor (Partner, Bird & Bird LLP) and Will Buckley (sports journalist and barrister).

Feedback from students attending the weekends was overwhelmingly positive. E&T would like to thank all the speakers as well as the members of the Inn who taught advocacy at the weekends and, in particular, Allan Briddock, Master Goss, Master Stuart Brown, Master Anthony Temple and Tim Penny who were instrumental in organising the weekends.

EDUCATION DAY & LECTURE NIGHT

The topics of this year’s two Education Days were *Ethics and Pupillage* and *Clinical Negligence*. Sessions included interactive exercises on ethics, talks from various pupils and barristers on their experiences at the Bar, an interactive mock trial and a talk from a medical health professional. Each Education Day was immediately followed by a Lecture given this year in February by Professor Cheryl Thomas (UCL) on *Why Judges and Juries Need (some) Academics* and in March by Dr Iyiola Solanke

(Leeds University) on *Academics and Practitioners: Common Occupants of Interplanetary Craft*.

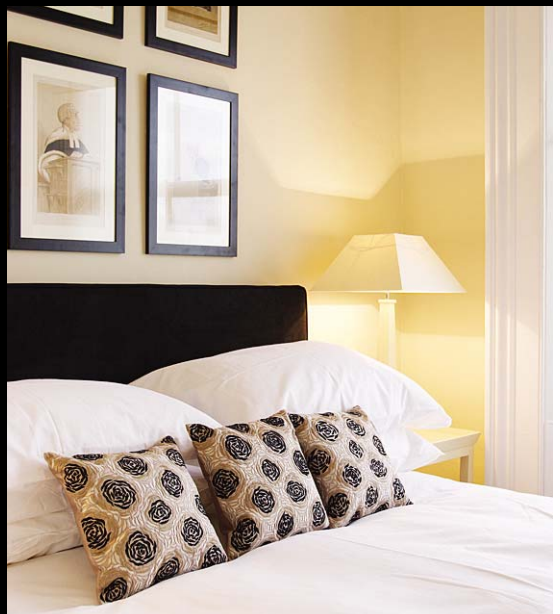

GARDEN NEWS THE DEVIL OR THE WIFE OF THE KING OF GODS?

A Christian myth claims that alliums were created from the footprint of the Devil as he left the Garden of Eden, while in North America a tribe in the Appalachian Mountains believe that spring arrives when the leaves of the alliums appear, and made a tonic from the plant, full of vitamins and minerals, to dispel winter ailments when there were no other greens during the cold and dreary months.

It is true that during the late winter and spring the leaves do cover the bare ground quickly, providing a fresh green backdrop to our vibrant tulip display in the High Border. Alliums are of course related to garlic and onions, and their leaves can be quite pungent, but surprisingly many cultivars have delicately-scented flowers which are used in expensive perfumes. We do not grow alliums for their medicinal or culinary use, but have introduced a variety of cultivars to bridge the 'green period' from mid-May to the end of June, which in the horticultural world is usually referred to as the 'June hole'. No great botanical skills are needed to achieve a six-week succession of alliums, it only involves staggering the early and late-flowering cultivars to ensure a lengthy season. 'Purple Sensation' is the first to bloom, which dominates the Chelsea Flower Show (and is a one-week wonder just like the show) but still worthwhile to grow *en masse* with 'Purple Rain' and *Allium jesdianum* to vary the height and size of the round purple heads. A good choice to continue the spectacle is to include the very regal 'Beau Regard' amongst them, which will hand the sceptre of colour and form to the mighty 'Globemaster' and 'Gladiator', which have flowers the size of footballs on strong stalks, standing a metre high above the soft colour and foliage of *Aquilegia chrysantha* and the stronger form of the wallflowers. Then as the perennials and dahlias begin to emerge there is another flush of alliums - the giant, *A. giganteum*, and the gnome, *A. christophii*, which is the lowest of them all but which boasts the largest flower structure, covered



with silver-mauve stars. As these great flower-heads set their seeds the allium succession is complete and they pass on the sceptre of summer to the asters, geraniums, heleniums and the later-flowering annuals.

I will leave it to you to judge if alliums are the work of the Devil or of Sachi – the wife of Indra, King of the Gods in Hindu mythology – who tried to sip the nectar of immortality, but could not digest it and expelled the liquid to the earth and from this the allium grew. From my point of view I like to think that we have brought a touch of immortality to this precious Garden.

It feels a little presumptuous to be asked to describe my time in the Choir of the Temple Church. This might seem odd on the face of it, given that I have been singing at the Temple almost every week for nearly a decade. But the hesitancy comes from the fact that I am one of a small minority of amateur – or perhaps more accurately semi-professional – singers in the back row of the choir. Thanks to the generosity of the Inns, one of the great strengths of the Temple Choir is its ability to select from among the best young professional singing talent in London, singers who are already undertaking stage roles in the great opera houses of Europe, who are soloists in concert and on disc, and who are already teaching and conducting across the UK.

When I left college, this was my ambition, too. Through a quirk of fate, however, I applied for a job at the BBC. I remember my Director of Studies telling me at the time that the BBC would suck me in and that I was giving up my chance for a singing career. Though I didn't believe him, he was right. The BBC is a very easy organisation to believe in

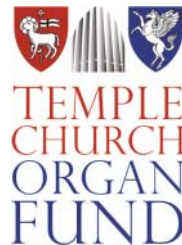
and a very difficult one to leave. I began there as a music producer for Radio 3 and have ended up leading BBC corporate strategy instead. Professional singing has had to be relegated to the weekends and occasional holidays.

But my eight years as a music producer for radio and television has come in handy even at the Temple. I produced the Choir's recent recording – *A Festival of Psalms* – and though my studio and editing skills felt perhaps a little rusty, I believe the result is first-class and confirms the choir's place as among the best in the country. But the relationship with the Temple has great personal value, too: every week I take part with pleasure and gratitude in its wonderful mix of high-quality music, its sense of tradition and theatre, its joy in the glories of the English language and its rightful sense of itself as a historic institution at the heart of the British establishment. Perhaps my day job and my weekend activities are closer in spirit than I realise...

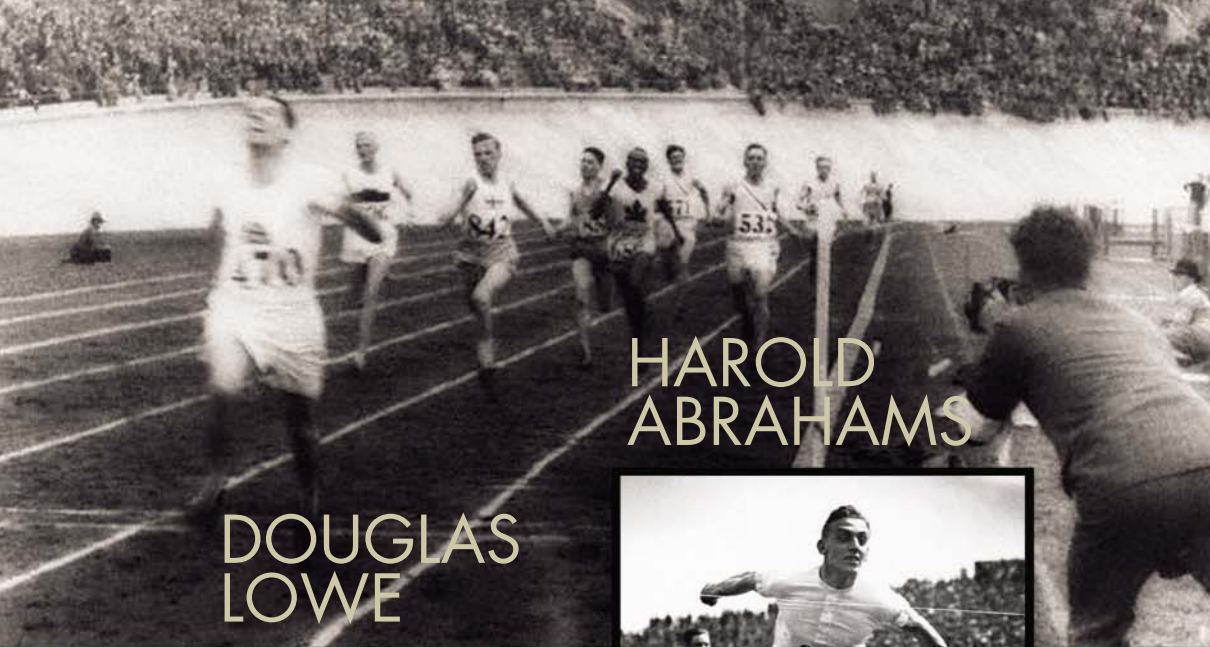
