reasons I accepted an invitation to join the steering group as one of the representatives of the Inn.

Keynote speakers at the first two Forums of last year included Master Hallett, who spoke about the difficult decisions she, in common with many women at the Bar, faced in the early part of her career and of the importance of maintaining a good work-life balance, as well as the value of strong role models to support and mentor women as they progress in their career. For my part it was invaluable to realise that difficulties faced by Master Hallett are difficulties faced by women at the Bar now. Childcare issues remain as much of an issue in the early days of Master Hallett as they remain for me now!

Master Gloster has been another eminent speaker from Inner Temple. She spoke vividly about her life at the commercial Bar but, largely as a result of her own positive career experience, posed the question whether women's networks such as the Forum were of real practical use, which prompted much discussion, particularly from the publicly-funded practitioners in the audience whose views derived from a very different set of experiences.

Attendance at these two Forums has not been limited to women. A number of men have attended on both occasions, and they are very welcome. What is unique about the Forums to date is that they have discussed issues and raised awareness of current issues facing women but also other minorities at the Bar. Young practitioners attending could hear how more senior practitioners have managed their career at the Bar by listening to the experience of others and by asking questions and gaining valuable assistance. The Bar as well as the judiciary can be perceived as lonely places and this is where the Women's Forum scores so highly. It provides those who want to know how others who have managed to cope or to make decisions relating to their careers have dealt with issues. As the talk by Master Hallett demonstrated to me – in many instances the same difficulties arise! So why not come and listen, participate and come away with ideas, thoughts and hopefully with having made new friends or at least meeting new people. On the last issue, this very much depends upon you, but the opportunity is quite simply too good to miss! All of us are attracted to the Bar by a love of communicating as well of course as a love of

the law – so use those communication skills at the next Forum.

Interest in the next Forum has been enthusiastic, with practitioners and chambers' administrators alike now registering to attend the next meeting and networking evening on 17 April.

Talks will include discussion about life for women practitioners at the publicly-funded bar and about judicial diversity. There will be time after the discussions for a glass of wine and an opportunity to meet members of the panel and the steering group.

So what does make this initiative different from others or what makes it relevant and of use to women practitioners and judges as well as to the entire Bar and judiciary? I hope I have answered that question in this article. It is that the Forum provides an opportunity to hear from those who are prepared to share their experiences and participate in discussions. Also, the topics may have an emphasis on women, but as can be seen from the programme, the talks and discussions will be relevant to all. The topics covered have changed in each Forum and, with the assistance of the steering group as well as of participants, we hope to continue to raise different issues.

The steering group have also proposed that workshops at both Inner and Middle Temple are held later this year to provide additional practical help over issues such as building a CV. # THE TEMPLE CHURCH ORGAN RESTORATION



ANDREW SCOTT – HEAD VOICER, HARRISON & HARRISON

**W**hen the organ was installed at the Temple Church in 1950, who would have thought that this remarkable gift from Lord Glentnar would last just over 60 years before earning a long overdue major clean and overhaul.

Having been nursed and coaxed along for the past 8-10 years it has now undergone a complete restoration by its maker. Soon, this remarkable organ built in 1923 by Harrison & Harrison Ltd of Durham, will once again accompany and colour the musical aspect of the Temple Church's liturgy, and unleash its formidable power and immense subtlety upon the London organ recital scene.

All of the components and the 3454 pipes have been painstakingly cleaned and restored by specialist organ builders in Durham and a site team led by foreman, John Oliver. Four new stops comprising 354 pipes have been added to the Great Organ, bringing the total number of pipes to 3808. The new stops have been made in the spirit and style of the 1920s, have been voiced to speak with the same harmonic language as the rest of the organ, and to the listener they sound as if they have always been there. The new additions have increased the organ's versatility by filling several dynamic gaps evident from when the instrument resided in a much less favourable acoustic in its original home in the ballroom at Glen Tanar House.

The final process of the restoration work

culminates with voicing and tuning. The difference between these two processes is often misunderstood. Tuning is a regular occurrence when each pipe is tuned to pitch and is brought into sync with its neighbours. This is generally undertaken once per month and coincides with changes in climate which affect the pitch and tuning.

Voicing happens at the very beginning of an organ's life and again to a lesser degree after a major cleaning. This lengthy process gives an instrument its "voice" - the pipes of each stop are balanced and blended together to create the musical palate and tonal architecture of the organ's character, and the different stops are balanced to match the building. This is what gives the organ its distinctive Harrison & Harrison Durham accent. It is done by listening to each pipe and stop in turn, and if any adjustments are necessary each pipe can be individually manipulated to speak the right timbre and at the right volume.

This painstaking final process, which is all done by ear, was started at the beginning of January, and recently finished ready for the organ's resurrection, rather appropriately, on Easter Day. During the process, visitors and the ever-tolerant volunteers at the welcome desk have been regaled with all sorts of extraneous noises emitting from the organ. Hopefully everyone who has been inconvenienced or shushed during this critical time will come back and hear the finished result, which is, quite simply, breathtaking.

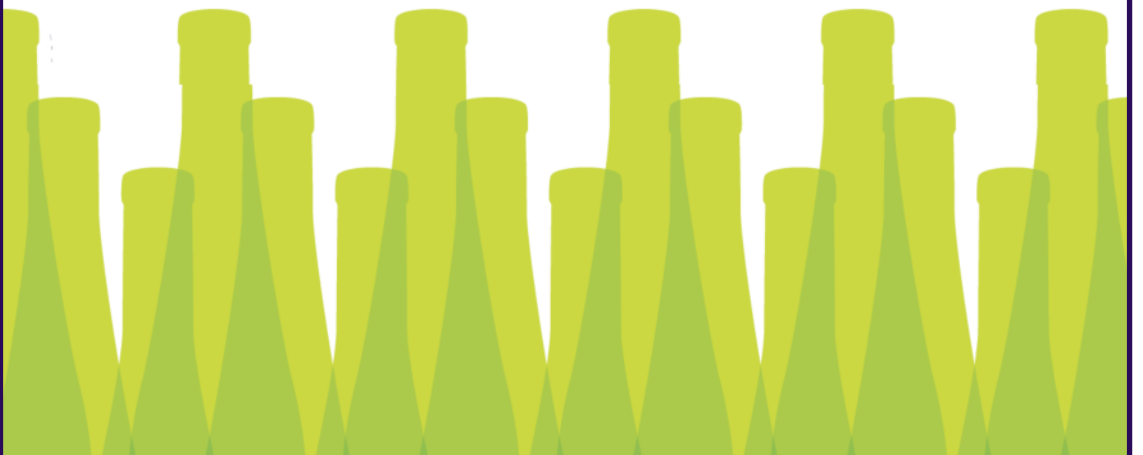

## POLICE OFFICERS LEARN ABOUT THE WORKINGS OF A CRIMINAL TRIAL

As part of the Inn's Police Liaison Scheme, an annual event was held at the Royal Courts of Justice on 15 February 2012. The event, which aimed to inform police officers about the workings of a criminal trial, consisted of a talk on giving evidence, a mock trial with an open jury and a question and answer session. Fifty officers attended from participating boroughs: Camden, Westminster, Islington, Kensington & Chelsea, Southwark and the City of London. The Police Liaison Scheme, chaired by Master Simon Davis, gives student members the opportunity to accompany officers on patrol to learn more about the work of the police. So far this year, over 30 students have shadowed police officers, with many more visits planned. The aim of the scheme is to promote good relations between the police, Bar and judiciary and foster a greater understanding of the entire criminal justice system. This is part of the Inn's larger

outreach work, which includes work with schools and educational charities.

## **THE INNER TEMPLE INTER-VARSITY MOOTING COMPETITION 2013**

On 3 February, 30 teams and judges from the UK and Ireland, as well as an excellent team of clerks, gathered to take part in the prestigious Inner Temple Inter-Varsity Moot 2013, sponsored by the ICLR and Tanfield Chambers. The day operates on a knock-out basis with two rounds before the quarter finals so we swiftly got underway with our moot problem which considered landlord and tenant law. It required mooters to address the question of what really constitutes a house for the purposes of the Leasehold Reform Act 1967 in light of several recent and instructive cases.

Round one saw some excellent opening submissions, with judges commenting on the creativeness and confidence with which students approached the moot problem. Following a delicious lunch in the Inner Temple Main Hall, we announced who would progress to the second round. While the mooters got underway, members of the Inner Temple Mooting Committee led a workshop for those teams who had been unsuccessful, offering advice, tips and suggesting a structure for researching, developing and executing a persuasive argument. Numerous teams have commented on how useful they found the session, which was a new concept for mooting competitions, and one we hope to apply in the future.

Gradually, arguments were honed, and the number of teams fell, until we were left with only four for the semi-finals: Kaplan, Bucks New University, Oxford Brookes and UCL all made it through thanks to their ability to

respond well to judicial interventions and offer convincing points. They were observed, and questioned, by experienced and challenging judges including Alastair Hodge of Inner Temple, Per Laleng, Dr Lars Mosesson of Bucks New University, Lynne Townley and two judges from Tanfield Chambers, Jonathan Upton and Paul Stevenson.

However, none of the students cracked under the pressure and finally Oxford Brookes and Kaplan both made it through to the final, judged by Lord Justice Keene, an esteemed Bencher of the Inn, alongside our judges from Tanfield. Oxford Brookes, acting for the Appellant, opened the moot, while Kaplan were for the Respondent. Both teams displayed careful attention to detail, and, having mooted the problem a number of times by this stage, were offering nuanced considerations on what could constitute a house, with close reference to a variety of case law. However, Oxford Brookes pipped Kaplan to the post and were the overall winners, being awarded not only the title, but mini pupillages at Tanfield Chambers and a year's subscription to the ICLR reports.

The Inner Temple Mooting Committee would like to thank all the teams, judges and clerks involved for a thoroughly enjoyable and instructive day, as well as all at Inner Temple for their contributions at every stage; we look forward to next year!

## INNER TEMPLE INTER-VARSITY DEBATING COMPETITION 2013

On Friday 1 and Saturday 2 February this year, the Inner Temple Debating Society hosted the Inner Temple Inter-Varsity Debating Competition 2013, kindly supported by Blackstone Chambers. 24 teams from across the country entered.

This competition is unique amongst undergraduate competitions - no other competition boasts a three course candle lit dinner, followed by a Grand Final judged by practising barristers. The competition was won

by Thomas Hosking and Harish Natarajan, a composite team from Oxford, the motion being 'This House Regrets that Lance Armstrong was Caught'.

This competition would not have been possible without the kind support of Blackstone Chambers. For 2014 the Debating Society is hoping to introduce a Mace as the official prize as an additional incentive for competitors.

## ADVOCACY AND PUPILLAGE APPLICATIONS DAY SAUL HERMAN, 3 TEMPLE GARDENS

On Saturday 23 February, some 24 members of the Inn gave up their Saturday morning to lend a hand to the Inn's BPTC graduates who are still struggling to find pupillage. This was the first time the Inn had run a day targeted specifically at this group of its members.

The event was overseen by Saul Herman, 3 Temple Gardens, who spoke at the start of the day to encourage everyone there to follow two of the first rules of advocacy in pursuit of pupillage: to know when you don't know (and so to use the day to ask frankly for help from the Inn) and to be persistent in pursuit of their goal. High ideals ringing in their ears, the students then got down to the detail of 3 hours spent improving their applications and skills.

All of those attending in search of help had had at least one pupillage interview already and many of those attending had been for several. The day, therefore, gave all concerned a chance to hone their advocacy skills, receive individual reviews of their CVs and pupillage applications, and to be put through their paces in a mock interview.

The trainers were drawn largely from those closest in time to the students, and included a mix of current pupils, new tenants and some more established practitioners. One student commented that it had been invaluable to have



advice given by those who had so recently been through the system.

Every student member spoken to had found the individual attention and feedback very useful for refining their applications. The advocacy component was for many, and especially those filling their time with paralegal work, a very welcome opportunity to lift their heads from paperwork and to keep up their presentation skills.

Finally, our thanks go especially to the trainers who gave up their time so generously and to Francesca Ellis from E&T who ensured that the organisation of the day was flawless.

## STUDENT RESIDENTIAL WEEKENDS

## INTERNSHIP SCHOLARSHIP IN MALAWI

In July 2011, the Honourable Society of the Inner Temple awarded me the Sir Joseph Priestley Internship Award, to enable me to travel to Malawi and undertake an internship with The Centre for Human Rights, Education, Advice and Assistance (CHREAA). CHREAA is a non-governmental organization which aims to make justice accessible to everyone through the Paralegal Advisory Service (PASI) and works to improve communication and co-operation between the police, prison service, courts and communities by offering legal advice and assistance to the poor and vulnerable.

The work of CHREAA is essential in Malawi, as over 90% of people going through the legal process will not have access to legal representation at any point, not least because there are only 28 legal aid defence lawyers in the whole country. The lack of legal representation has led to severe overcrowding in Malawi's prisons, with prisons with capacity for 800 prisoners currently holding nearly 2000 people. A large proportion of these are detained on remand in pre-trial detention. Unfortunately, most remandees are unaware of their right to bail or when and how to apply for it and, even if granted bail, most cannot afford to pay the bond or provide a surety. As a result, people are imprisoned on remand in inhumane and degrading conditions for years before they have even had the chance to have their case heard.

My planned role at CHREAA was to assist the paralegals in their efforts to prepare as many bail applications as possible for the adults and juveniles currently detained without trial in prisons throughout Malawi. I had hoped to use my legal training to interview prisoners and draft affidavits and submissions. After arriving at the CHREAA office on my first day, however, I was informed that all 200 courts across Malawi had been closed for the past few weeks due to a strike by court staff over salary increases which had been promised in 2005 after the last strike. Consequently, no bail applications had been filed for several weeks and there was no sign of an agreement being reached.

While waiting for some solution to the impasse, I was able to take on several other

projects. I started interviewing prisoners to draft individual case appeals, alleging breaches of domestic and international law, which were submitted to the UN Working Group on Arbitrary Detention. During my interviews at Chichiri, the largest prison in the Southern Region, prisoners told me that since the start of the strike, 60 capacity cells were holding over 200 men; some attempting to sleep standing up with the remainder sleeping shoulder to shoulder on the cell floor. The Prison Service's budget was not increased to address the congestion and prisoners were barely surviving on one meal every two days. As one can imagine, it was not a difficult task to identify examples of inhumane and degrading treatment.

I also worked to find and interview family members of individuals still waiting to be resentenced after the decision in *Francis Kafantayeni and others -v- The Attorney General of Malawi* [2007]. Although this landmark decision abolished the mandatory death penalty and declared that the death sentences of all the prisoners on death row as unconstitutional, nearly 200 individuals are still detained in Zomba Maximum Security Prison waiting to be re-sentenced.

As the weeks passed, it became clear to me that, no matter how hard they tried, Malawi's 28 legal aid lawyers and 10 paralegals could not possibly tackle the ever increasing amount of people passing through the criminal justice system. With an extremely generous donation from Matrix Chambers, CHREAA's paralegals and I were able to found the Malawi Bail Project, which aims to educate prisoners about their

rights, the court process and how and when to apply for bail. Much of this work was achieved through the distribution of legal education booklets at Magistrate Courts and Police Stations, combined with training days for law enforcement officials where we discussed the issues surrounding bail commonly experienced by those going through the legal process. By educating those accused of their legal rights at the beginning of the legal process, either at the police station or on their first court appearance, we hope to increase the number of bail applications made and subsequently reduce the number of remandees in pre-trial detention.

We are incredibly grateful to Matrix Chambers for giving us the opportunity to carry out what we believe will be an extremely successful project preventing a huge number of people from suffering the same injustices those currently in pre-trial detention are forced to endure every day. We are hoping to expand the project to areas outside Blantyre – Malawi's commercial capital – particularly as bail provision elsewhere in the country is sometimes even less effective. # STRIVING FOR PERFECTION

**T**he truism that a garden is never fully completed has been repeated by the finest horticulturalists since Nebuchadnezzar issued his first instructions to the gardeners in Babylon. A design is put in place, with much attention paid to making its basic structure cohesive, ensuring the anchor plants are in flourishing good health and that form and colour engage the spectator's senses. Yet after all that planning and execution a detail is missing or misaligned or just plain wrong and the gardener notes the mistakes or misjudgements and determines that the next season will be another step on the road to perfection.

Only the notebook stays on the desk as another part of the garden is to be over-hauled or refreshed: a new woodland garden is to be laid out, the re-configuration of the peony garden is in need of adjustment, the High Border is stamping its prima donna foot and demanding attention. Then, suddenly –almost unexpectedly – the moment comes when there is time for fine-tuning, for tweaking and polishing an area which has nagged at the back of the mind for too long, and this is the stage we have reached in the War of the Roses border for our summer planting.

The spring displays of a variety of tulips,

wallflowers and forget-me-nots suit that lengthy space well, and the yew dividers and buttresses have now grown into the shape we imagined, giving room for more intricate planting in the midst of it and allowing us the luxury of concentrating on such detail. Last year we planted the central bay in a quite different pattern to its neighbours (a scheme flatteringly covered by *Which? Gardening* in its January issue) and this year we are expanding this notion into three of the 'rooms' in the central stretch by planting them with a selection of bold colours in the magenta spectrum from the prominent blooms of dahlias, zinnias and antirrhinums. Woven through them, matrix style, will be cosmos in softer shades of pink, *Ammi majus* with feathery foliage and white umbels, together with tall, airy eucalyptus and the small mauve flowers of *Verbena rigida*. In the other bays on either side we will repeat the combination of cosmos, eucalyptus and *Verbena rigida* so that the varying heights and differing forms flow through the intricate central space and into the next bays. All of which embraces the golden rule of garden design: varying height, form and colour.

In my mind's eye I see it perfectly, and we are determined (drought and flood allowing) to re-create that vision. We cannot guarantee perfection, gardeners are far from infallible, but at least we won't have Amytis of Media (aka Mrs Nebuchadnezzar) demanding that plants hanging from the roof of Paper Buildings are required as a backdrop.

## LIBRARY SURVEYS

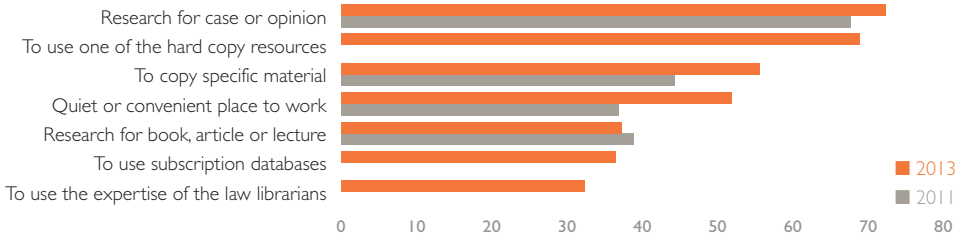

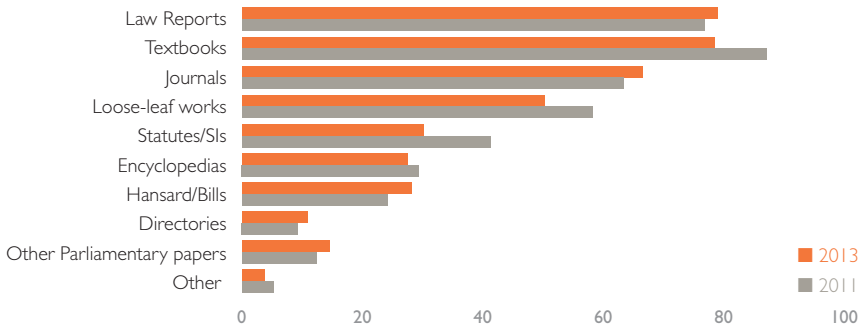


The Treasurer selects the winning entries in the prize draw

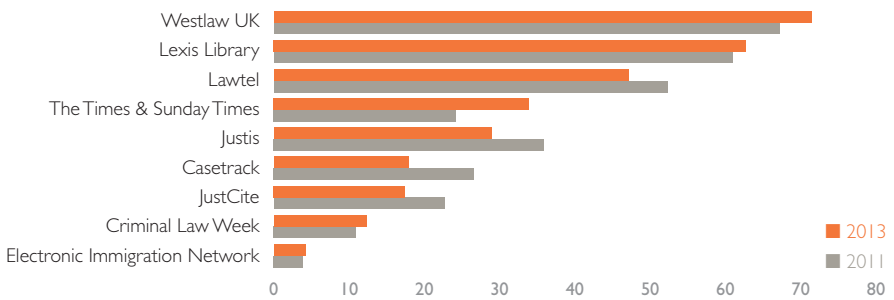
### WHAT ARE YOUR REASONS FOR VISITING THE INNER TEMPLE LIBRARY?



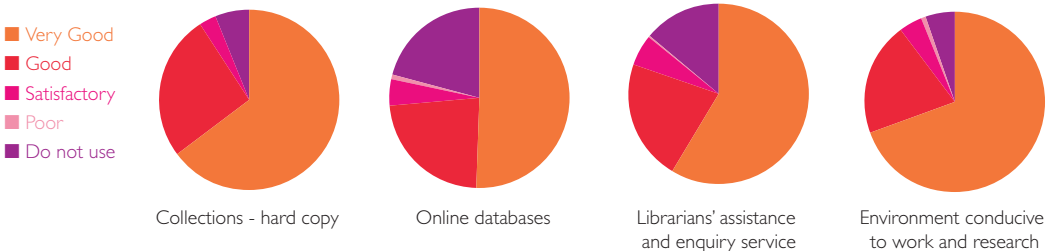
### WHICH HARD COPY RESOURCES DO YOU USE WITHIN THE LIBRARY?
