of the legal professions from other jurisdictions, both judges and lawyers, that you realise the esteem in which the Inns are held and that this applies particularly to the Inner Temple.

Hardly a week goes by without a visit from a distinguished foreign lawyer and, increasingly, the Ambassadors and High Commissioners of foreign countries are contacting the Inns for an exchange of views and to understand why students from their countries want to qualify for the Bar. Last July, in addition to British students, I called students from 14 other countries to the Bar. The post graduate degree of Barrister at Law is a highly regarded addition to a CV. This is not merely because of the legal training that is necessary to obtain it but because it carries with it the understanding that the recipient has been taught the art of advocacy and, perhaps more important, the ethics and ethos of the profession by the Inns.

This year I have been privileged to be invited to travel to Malaysia, Singapore and Bhutan to cement our on-going relationships with those jurisdictions and to communicate the message that the Inn is a thriving and relevant institution in the 21st Century. Happily it is not a difficult message to convey. We are, of course, well known in Malaysia and Singapore but the opportunity to meet and to understand more precisely why they

value our relationship is more than welcome. I shall however be the first Treasurer to travel to Bhutan, a country I first visited some five years ago as a tourist and fell in love with. It adopted its first Constitution in 2008 (having previously been an absolute monarchy) and many of the fundamental rights of the citizen laid down in it plainly have their origin in the Magna Carta. Just as an example, Article 7.1 reads:

*All persons shall have the right to life, liberty and security of person and shall not be deprived of such rights except in accordance with the due process of the law.*

It is very rewarding for the Inn to be asked to play a part in the process of establishing a legal system in Bhutan which promotes the Rule of Law. Our relationship with Bhutan is to be cemented by the forthcoming presentation by the King of Bhutan of “The King of Bhutan’s Cup” for the Inner Temple Intervarsity Mooting Competition. I trust I shall be able to bring it back through customs!

# AN INTERNATIONAL DIMENSION

**W**e do not always appreciate the high standing that the Inns of Court are held in abroad, and the respect that is accorded to the title of barrister.

I doubt many in the law would regard the Inner Temple as a global brand and might positively wince at the idea. And yet every month the Inn’s international connections seem to grow and strengthen. One sign of this is the steady flow of lawyers and Judges from across the world who ask to come and see something of who we are and what we do.

In the month of July alone we welcomed a Supreme Court judge from Bangladesh, the Governor General of Barbados, a senior family Australian judge, plus visitors from Hong Kong, Texas, Poland and an African prisons project.

Our student profile reads like an atlas as well (as the recent Call list below demonstrates) and we are as keen to stay in touch with our members in The Bahamas and Malaysia as we are in Birmingham and Manchester. Indeed we will shortly launch an international e-newsletter to ensure this

happens even more regularly. All contributions welcome.

One country that took up the Inns of Court model 25 years ago to facilitate a better dialogue and civility between lawyers, judges, academics and law students, is the United States with local chapters in just about every major city. They do not Call students to the Bar (their State Bar Associations do that) but in many other respects they look to us as a template for ethical behaviour and collegiality. Chief Justice Zakaria of Malaysia has recently said much the same for his own jurisdiction.

Each year the Treasurer and Sub-Treasurer visit our members in S E Asia and by the time you read this we will have been to Malaysia and Singapore with the Treasurer heading for Bhutan while I call in at Qatar, Brunei and Sarawak. We will be assured of a warm welcome and with many speaking opportunities to tell our guests that Inner Temple is in fine form and happy to have a place in the international arena.

# GREAT STRIDES FROM THE BAR

**T**he three years since being Called to the Bar at the Inner Temple have been momentous and interesting. Indeed my African travels (and travails) have made me realise how transferable one's Bar skills can be, and such a great platform spurring me upwards and onwards to unexpected heights. So what heights am I talking about? Initially I worked at the British High Commission, (UK Trade and Investment) based in Lagos, Nigeria. Admittedly there were parts of me that wanted to experience a more 'tangible' law in a different and more trying setting. So, once exposed to law and commerce in Nigeria, I went further in seeking a tangible application of the law with Baroness Cox at the House of Lords, fighting for the development of the law in women's rights under Sharia law. Having had this very real and interesting experience, I was head-hunted to take my skills back to Nigeria. So, in the midst of thoroughly engaging and relevant pupillage interviews, I found myself again working in Nigeria but this time for a consultancy company in Abuja. It was whilst dining my way through the 'hot



pepper' soups in Nigeria that I met a senior Director of De La Rue and was introduced to what is now my current workplace: working for a brilliant and highly reputable company as a Relationship Manager for Nigeria and the African Union. No sooner was I offered the role than my legal antennae were telling me this was very much the right direction: legal skills and knowledge, enterprise, ethics and, of course, Africa: all my aims in one! So yes, another step in a different direction but it is a truly thrilling and engaging experience as I learn my way in a company which takes ethics in the work and market place to a highly respectable level.

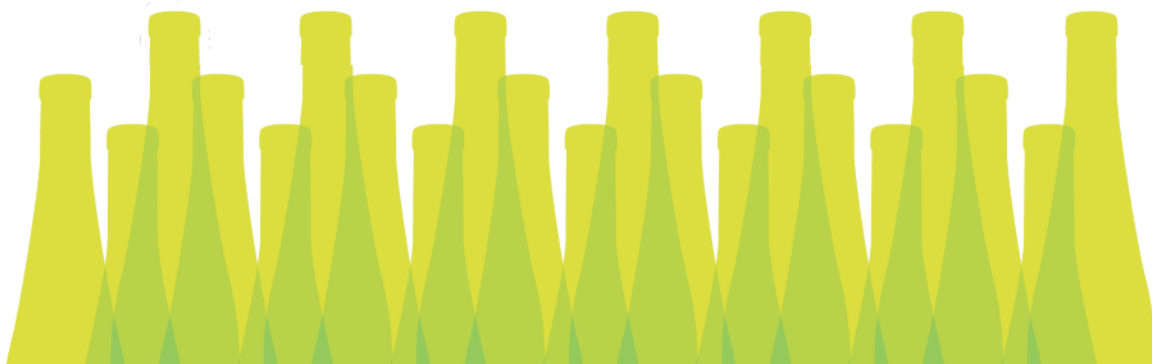

## QUESTION AND ANSWER DAY FOR PROSPECTIVE STUDENTS

A Question and Answer Day for Prospective Students was held on Sunday 16 June. Q&A Day is an annual event held by the E&T Department in conjunction with the Junior Bar Association (JBA) at the Inner Temple for university students considering a career at the Bar. The full-day event included workshops on all aspects of training for the Bar, the Inn's scholarships programme, writing a legal CV, gaining pupillage, life as a tenant, opportunities at the Employed Bar and more. A drinks reception was held after the workshops to provide participants with a chance to speak

one-to-one with members of the Inn.

140 university students attended from over 40 universities across the UK. The sessions were very well received with students responding that they have a much greater understanding of what is involved in training for a career at the Bar and practice.

The E&T Department would like to extend a special thanks to all those junior barristers, pupils and student members who ran workshops throughout the day.

## INNER TEMPLE SCHOOLS PROJECT

On 12 July the Inner Temple hosted the final day of the Bar Council and Social Mobility Foundation's Bar Placement Week. The scheme gives selected state sixth form students an introduction to the Bar through a week-long placement in Chambers, combined with other activities such as a court visit. The final day involved sessions led by members of the Advocacy Training Council and a reception where winners of the annual essay prize were announced.

The Inn hosted school students on the University of Sussex 'Aiming for Law' project on 17 July where they learned more about a career at the Bar. The students heard from Gemma Hobcraft (Doughty Street Chambers) about life as a junior barrister.
